2. The Observer must:
 - Hold a professional qualification which in the opinion of the Secretary General of the APAA would entitle him/her membership if the Observer was resident in the APAA region; or
 - be a practicing patent attorney in his/her own country; or
 - be connected by Convention or Treaty, as determined by the Secretary General of the APAA.
3. The Observer must arrange for this Sponsorship Letter to be completed, signed and dated by an APAA member sponsor.
4. If the Observer does not have an Observer ID, he/she can obtain one from the Secretary General of the APAA via the Secretariat. Issuance of Observer ID is subject to the Observer Protocols and Approval of the Organizing Committee.
5. The Observer is required to send this original Sponsorship Letter to the Secretariat of the APAA 18th General Assembly and 68th & 69th Council Meetings. Upon the receipt of Observer ID, the observer is highly recommended to continue to registration process online at www.apaa2018.com.
